

## **Conditions for membership of NAF Odette Sweden**

### ***Purpose of the NAF / Odette Sweden***

NAF means "Networking for Business Development in the supply chain" and is inspired by similar cooperation in other countries with a successful automotive industry and is ultimately intended to boost competitiveness through effective and integrated supply chains.

NAF creates a forum for exchange of experiences, skills development, improvement and influence in matters having to do with the supply chain function and the relations between the parties in the supply chain. Specifically it is about logistics, EDI and data communications.

### ***Who can join?***

Since a long time the automotive industry, SKF and some IT companies are participating in Odette Sweden. Some years ago, even suppliers were invited to participate.

Membership of the NAF / Odette Sweden is primarily intended for the following categories:

- Suppliers in the automotive industry
- Other manufacturing companies with similar activities
- The transport and logistics company
- Programs Department stores and other IT companies

### ***What do you get as a member of the NAF / Odette Sweden?***

For participating companies, the membership gives the following:

#### **Access to information**

- Access to publications (EDI Auto ID / RFID, communications, logistics, among other: MMOG / LE, FAI)
- Discounts on seminars and courses
- Access to information on ongoing projects and current issues through meetings, seminars and webinars

#### **Participation in activities**

- The ability to propose, participate in and influence various projects and committees
- Opportunity to jointly apply for funding from various government agencies and programs

#### **Impact**

- Ability to support a joint initiative to strengthen the suppliers' position and work to improve skills and competitiveness
- Ability to influence the authorities, politicians and automotive manufacturers

### **Exchange of experience and networking**

- Member companies are invited to an annual meeting where the activities of the NAF / Odette Sweden are reported, both in recent years as well as plans for the near future. At this annual meeting, the member companies can submit proposals, and the meeting will also appoint members of the NAF Steering Group.
- Member companies can notify contacts of various current issues, they will be part of an active network of information exchange and skills development.

### **Charge**

Membership fee for membership of the NAF / Odette Sweden amounts to:

- SEK 8000 for manufacturing companies as well as for service providers in logistics and transport (for individual companies, not groups) with annual sales less than SEK 50 000 million.
- SEK 30,000 for software houses and IT companies with annual sales of SEK 15 million
- SEK 15,000 for software houses and IT companies with annual sales less than SEK 15 million.

The fee is paid annually in advance, VAT will be added.

### **Exit**

Resignation as a member of the NAF / Odette Sweden can only be made at year-end. A membership shall be terminated by written notification to Odette Sweden AB not later than three months before the fiscal year. The Board may, however, permit shorter notice. The exiting is not entitled to recover the fees paid or share in Odette Sweden assets.
